

## Directions

### From Orange Beach:

I-65 North to Herron Street Exit (exit #172);  
Take exit 172 and veer right at the traffic signal onto Herron St. (one-way);  
Continue on Herron St (which will become Bibb St) and at the 1<sup>st</sup> traffic signal, turn right onto Catoma St.;  
Continue on Catoma St and at the 2<sup>nd</sup> traffic signal, turn left onto Church St.;  
Continue on Church St (1 block) and at the 1<sup>st</sup> traffic signal, turn right onto Lee St and immediately move into the left lane;  
Turn left at the traffic signal onto Adams Ave. (one-way);  
Immediately turn right to enter the parking lot.

**The parking lot access code and space # will be provided when attendance is confirmed.**

Note: *The traffic signals on Lee St can be confusing.*

*After you turn right onto Lee St, you can see the courthouse entrance doors to my section of the courthouse on the right. Enter through the middle doors; stop at the security station and the security officers will assist you with the entrance process.*

**Return Directions to Orange Beach:** Exit parking lot and turn right onto Adams Ave.

At the 1<sup>st</sup> traffic signal, turn left onto Perry St (one-way).

Continue on Perry St. At the 4<sup>th</sup> traffic signal, turn left onto Madison Ave.

Continue on Madison Ave. which will change to Bibb St.

Continue on Bibb St. (you will pass the new Marriott Renaissance and the Civic Center).

Continue on and Bibb St. in the right lane; as you approach the Capitol Inn [**do not proceed straight to the Stop sign**], veer right and Bibb St will become Clay St (one-way).

At the 2<sup>nd</sup> traffic signal on Clay Street, turn left into the middle lane onto Dickerson St.

Go 1 block and you will access the on-ramp for I-65 South.

### **From Auburn:**

I-85 South to the Downtown/Union St exit (exit #1)

Take exit 1 and continue on South St in the right lane (one-way street; runs parallel to the interstate);

Turn right onto Perry St. (South St's right lane becomes a right-turn only onto Perry);

Continue on Perry St and at the 4<sup>th</sup> traffic signal, turn left on Washington St. (one-way);

Stay in the left lane on Washington St; the lane will curve to the left and become Lee St.

At the traffic signal, turn left onto Adams St. (one-way). ***Careful... drivers often turn left onto Adams St. from the Lee St middle lane but there are no dual turn lanes from this section of Lee St.***

Immediately turn right to enter the parking lot.

**The parking lot access code and space # will be provided when attendance is confirmed.**

***Note: After you curve left onto Lee St, you can see the courthouse entrance doors to my section of the courthouse on the right. Enter through the middle doors; stop at the security station and the security officers will assist you with the entrance process.***

**Return Directions to Auburn:** Exit parking lot and turn right.

At the 2<sup>nd</sup> traffic signal, turn right on Lawrence St (one-way).

Continue on Lawrence St. At the 4<sup>th</sup> traffic signal, turn left onto Arba St. (one-way).

Get into the middle lane on Arba St. The middle lane will access I-85 North and allow you to change lanes before reaching the Ann St exit. After accessing I-85 North, move over 1 lane to the left.

### **From Birmingham:**

I-65 South to Clay Street Exit (exit # 172)

Take exit 172 and continue through the intersection at the traffic signal;

At the next intersection, turn left onto Herron St. (one-way);

Continue on Herron St (which will become Bibb St) and at the 1<sup>st</sup> traffic signal, turn right onto Catoma St.;

Continue on Catoma St. and at the 2<sup>nd</sup> traffic signal, turn left onto Church St.;

Continue on Church St (1 block) and at the 1<sup>st</sup> traffic signal, turn right onto Lee St and immediately move into the left lane;

Turn left at the traffic signal onto Adams Ave. (one-way);

Immediately turn right to enter the parking lot.

**The parking lot access code and space # will be provided when attendance is confirmed.**

Note: ***The traffic signals on Lee St can be confusing.***

***After you turn right onto Lee St, you can see the courthouse entrance doors to my section of the courthouse on the right. Enter through the middle doors; stop at the security station and the security officers will assist you with the entrance process.***

**Return Directions to B'ham:** Exit parking lot and turn right onto Adams Ave.

At the 1<sup>st</sup> traffic signal, turn left onto Perry St (one-way).

Continue on Perry St. At the 4<sup>th</sup> traffic signal, turn left onto Madison Ave.

Continue on Madison Ave which will change to Bibb St.

Continue on Bibb St. (you will pass the almost –finished new Marriott Renaissance and the Civic Center renovation).

Continue on and Bibb St. in the right lane; as you approach the Capitol Inn **[do not proceed straight to the Stop sign]**, veer right and Bibb St will become Clay St (one-way).

At the 1<sup>st</sup> traffic signal on Clay Street, proceed through the intersection and turn right to access the on-ramp for I-65 North.
